Message From CEO

Dear Families,

I have a few updates and requests to share this week!

- 1. Per the PDPH, the mask mandate in schools has been relaxed and masks are now optional. If you would like your child to wear a mask, please send them to school with one. As a reminder, the guidance states that all schools will require masks again for the week following spring break.
- 2. Every US household is eligible for two sets of four covid tests. Check $\underline{\text{this website}}$ for more information about how to order yours.
- 3. The PDPH released new guidance on how to handle situations when there is exposure to a positive case of Covid in a school. Please see the message below from our Covid Coordinator.
- 4. Federal law mandates that masks still be worn on all public transportation and school buses. If your child takes SEPTA or rides the school bus, you must provide them with a mask for travel.
- 5. I wanted to call your attention to a petition that has been organized to send to Governor Wolf around his proposals targeting charter schools. Please consider taking a look and signing it. You can find it here.
- 6. We are entering hiring season at Wissahickon. If you know of any teachers who would like to join our schools, please direct them to <u>our website</u> to see our open positions! We know there is a national and local shortage of teachers and appreciate your help in spreading the word!

Essentials

Message from COVID Coordinator

The PDPH has issued their new guidance for in-school COVID exposures in our new mask optional environment. WCS has chosen the Mask to Stay option. If a class experiences a positive case of COVID the following steps will occur:

- Families will be notified immediately of the positive case
- All students in the class will return to wearing a three ply surgical or KN95 style mask for 10 days from the day of exposure. (WCS will supply masks)
- Asymptomatic close contacts of the positive case will be tested 5 days from the exposure

Families must continue to monitor and report any symptoms on the daily Ruvna screening. Students who experience symptoms from an in school exposure will be required to quarantine for ten days from the onset of symptoms. Alternatively, the student could be tested on day 5 from the start of symptoms and with proof of a negative test may return on day 7. Should a family need a test kit the school will make one available. At any point if a student tests positive for COVID they will be required to isolate for ten days from the date of the positive test.

We will continue to monitor the school community's health and at any point should the data support, will return to full masking and more strict quarantine guidelines. Thank you for your support and cooperation that has allowed us to remain healthy while prioritizing safe in-person learning. Please do not hesitate to contact me if you have any questions regarding the new guidance.

Virtual T2 Report Card Conferences

Report Card conferences will be held virtually from March 16, 2022 - March 18, 2022 between 1:00 PM and 4:00 PM. Please select a date/time convenient for you. If your child has more than one core teacher (4th-8th grades) and you would like to talk with a teacher other than the homeroom teacher, please get in touch via ClassTag. Unfortunately, due to time constraints, we do not have slots available to meet with more than your child's homeroom teacher this year in a formal way. Please note the conference scheduling system will close by the end of the day on Friday, March 11, 2022 at 3:00 PM. Please make sure you have scheduled a conference for your student by this time. If you scheduled with the wrong teacher the conference will be deleted and a new one will be scheduled for you.

PSSA Information

The PSSAs begin the week of April 26th for students in grades 3-8. The testing windows are as follows:

- April 26-28: English Language Arts
- May 4-5: Mathematics
- May 10 and 12: Science (Grades 4 and 8 only)
- May 9-13: Makeups as needed

Some parents have expressed interest in having their children "opt out" of the PSSAs due to religious beliefs. While a family can opt a child out at any point, we are requesting this year that you provide us with notice prior to Spring Break (by Friday, March 25) so that we can make adequate preparations for how they will spend testing time.


