Message From CEO

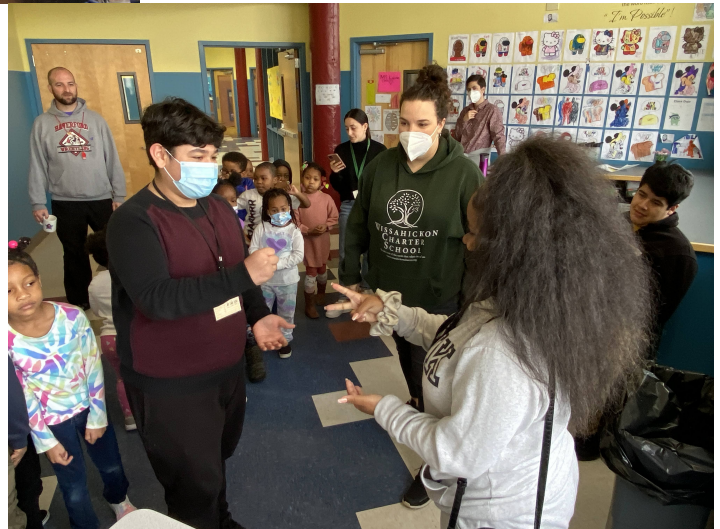
Dear families,

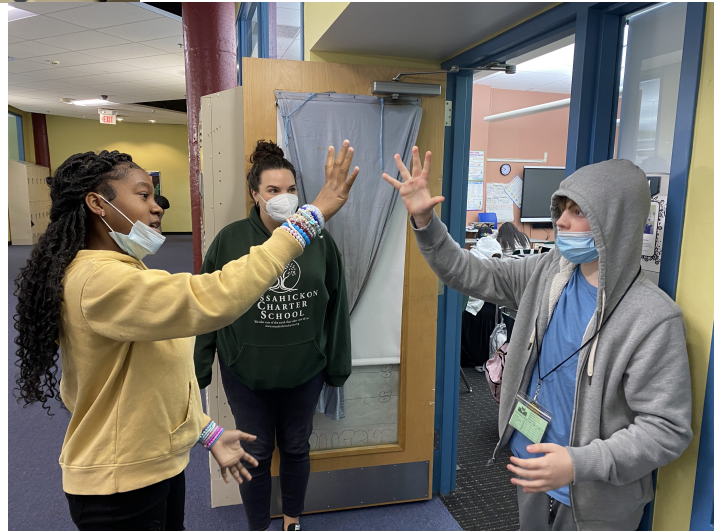
I hope you have nice plans for the upcoming spring break. The forecast looks promising so it could be a good time to get outside! I'm writing today to give you a couple of reminders about what to expect after spring break regarding Covid safety.

We are required by the PDPH to wear masks for the week following spring break. At this time, we do not know if this will need to be extended beyond that week or not. This week [the city started suggesting that people return to wearing masks indoors](#). We will monitor the news and updates and keep you posted. Please make sure that your child knows that masks are required after break.

I also want to let you know that we have sent some free Covid 19 tests home with your child. We are asking that you test your child Sunday evening or the morning of Monday, April 18th before they arrive at school. You only need to report the results if your child tests positive for Covid 19. You can report these through RUVNA and then we will reach out to you.

PSSA Information

The PSSAs begin the week of April 26th for students in grades 3-8. The testing windows are as follows:

- April 26-28: English Language Arts
- May 4-5: Mathematics
- May 10 and 12: Science (Grades 4 and 8 only)
- May 9-13: Makeups as needed

Some parents have expressed interest in having their children "opt out" of the PSSAs due to religious beliefs. While a family can opt a child out at any point, we are requesting this year that you provide us with notice prior to Spring Break (by Friday, March 25) so that we can make adequate preparations for how they will spend testing time.
